C I R C U L A R

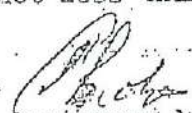
In supersession of above mentioned two Circulars and in exercise of the powers vested in, under rule 47 of the Maharashtra Country Liquor Rules, 1973, the Commissioner of Prohibition and Excise, Maharashtra State, Bombay hereby directs as follows:

- (1) The Prohibition and Excise Officer while issuing Transport Pass in Form C.L.XIV for transport of duty paid country liquor shall in the sub-joined form to the said transport pass mention batch No. in column 3 below the No. of bottles/containers mentioned therein.
- (2) The holder of C.L-II licence while issuing Transport Pass for duty paid country liquor in Form C.L.XVII shall, in the Sub-joined form to the said pass mention batch No. of each variety of country liquor allowed to be transported.
- (3) The holders of C.L-I as well as C.L-II licensees;
 - a) Shall not sell any country liquor except for cheque/draft.
 - b) The Cash Memos shall be in triplicate which shall be signed by licensee or his authorised agent/servant. Also, the licensee may make out cash memos ~~in such~~ in such numbers exceeding three, as the case may be, required by him with previous permission in writing from the Superintendent of Prohibition and Excise of his district.

- c) The original copy of the Cash memo shall be handed over to purchasing licensee, the duplicate copy shall be retained by issuing licensee on his record and triplicate shall accompany the truck carrying consignment.
- d) Details of Cash memo- The Cash Memo shall clearly show:-
- i) The name of the licensee, his licence No. and the nature of licence held by him.
 - ii) The name of the purchasing licensee, his address, his licence No. and the nature of licence held by him.
 - iii) Details regarding variety of country liquor, the quantity with No. of Containers i.e. barrells and/or bottles of country liquor and the strength and batch No. of each variety.
 - iv) Amount charged inclusive of duty in respect of the sell of such country liquor.
- e) Counters of these cash memos, shall be preserved by the concerned licensees for a period not less than two years from the date of issue.
